## THE TERRY SCHOLARSHIP FUND

was established in 1999 by Mary Virginia Terry in honor of her beloved husband, C. Herman Terry, a Christian man whose dedication to higher education spanned his entire life.

Mr. Terry was born in Ray City, Georgia. Herman, as he was known by his friends, graduated from the University of Georgia. He spent most of his adult life in Jacksonville where he founded the Dependable Insurance Group of companies.

Mr. Terry was actively involved in civic and business affairs in Jacksonville and was a director or trustee of several institutions including Jacksonville University, the University of Georgia, First Union National Bank, Cummer Museum, the Jacksonville Symphony and many other organizations. In 1991 the University of Georgia College of Business was renamed in honor of the Terrys.

## PURPOSE

## ELIGIBILITY

Members of Ortega United Methodist Church and any other Methodist Church within the area encompassed by the Jacksonville District of the Florida Annual Conference.

## AVAILABILITY

The dollar amount of scholarships awarded may vary from year to year and is dependent on the income generated by the Terry Scholarship Endowment Fund and the number of qualified applicants. Scholarship recipients and previous applicants may apply in subsequent years.

## SELECTION

The Terry Scholarship Committee of the Ortega United Methodist Church will select deserving students based upon the submitted applications, related materials and personal interviews.
